- iii). Evidence of current Pension compliance Certificate valid till 31st December, 2019.
- iv). Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2019.
- v). Evidence of current Nigeria Social Insurance Trust Fund (NSITF) compliance certificate valid till 31st December, 2019.
- vi). Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of the Interim Registration Report (IRR) expiring on 31st December, 2019 or valid certificate issued by BPP.
- vii). Sworn affidavit disclosing whether or not any officer of the relevant committee of the Cross River Basin Development Authority or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars.
- viii). Company's Audited Accounts for the last three (3) years (2016, 2017, 2018).
- ix). Evidence of financial capability to execute the project including **Reference Letter** from a reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed.
- x). Company profile with the

curriculum vitae of the key staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON ETC.)

- xi) Verifiable documentary evidence of at least three (3) similar jobs executed in the last five (5) years including Letters of Award, Valuation Certificates, Job Completion Certificates.
- xii) List of Plants/Equipment with proof of ownership/lease (where applicable).
- xiii) For joint ventures/Partnership, Memorandum of Understanding (MoU) should be provided (all the eligible requirements are compulsory for each joint venture partner)
- xiv) All documents for submission must be transmitted with a Covering/Forwarding letter under the Company/Firm's letter Headed Paper bearing amongst others, the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC). Contact Address, Telephone Number (preferably GSM No.) and email address. The letter headed paper must bear the names and nationalities of the Directors of the company at the bottom of the page duly signed by the authorised officer of the firm.
